It introduces the participants to the concept of 'medicalisation' and then focuses on two instances as illustrations – hormonal contraceptives and commercial surrogacy and Assisted Reproductive Technologies (ARTs). Presentation on women's movement against Norplant in Bangladesh and Discussion The session would focus on the pioneering campaign led by the women's movement in Bangladesh against Norplant (a contraceptive using hormonal implants) that was a historic precursor to various other South Asian campaigns on women's health. Session will focus on the issues and concerns, including ethical issues that were raised by the campaign in Bangladesh and elsewhere.
